Manitoba Regulation 52/93 amended

1 The Personal Care Services Insurance and Administration Regulation, Manitoba Regulation 52/93, is amended by this regulation.

2 Section 1 is amended

(a) by adding the following definition in alphabetical order:

"**common-law partner**" in relation to an insured person, means a person who, not being married to the insured person, cohabitated with the insured person in a conjugal relationship for at least one year immediately before the insured person's admission to a health facility; (« conjoint de fait »)

(b) in the definition "separated", by adding "or common-law partner" after "spouse"; and

(c) by replacing the definition "spouse" with the following:

"**spouse**", in relation to an insured person, means a person to whom the insured person is married. (« conjoint »)

3(1) Subsection 6(1) is amended by striking out "\$61.40 per day effective August 1, 2002" and substituting "\$62.10 per day effective August 1, 2003".

Modification du R.M. 52/93

1 Le présent règlement modifie le Règlement sur l'assurance relative aux services de soins personnels et l'administration des foyers de soins personnels, R.M. 52/93.

2 L'article 1 est modifié :

a) par adjonction, en ordre alphabétique, de la définition suivante :

« **conjoint de fait** » Personne qui a vécu dans une relation maritale avec un assuré sans être mariée avec lui, pendant une période d'au moins un an ayant précédé l'admission de l'assuré dans un établissement de santé. ("common-law partner")

b) dans la définition de « séparé », par adjonction, après « son conjoint », de « ou de son conjoint de fait »;

c) par substitution, à la définition de « conjoint, de ce qui suit :

« **conjoint** » Personne avec laquelle l'assuré est marié. ("spouse")

3(1) Le paragraphe 6(1) est modifié par substitution, à « 61,40 \$ à compter du 1^{er} août 2002 \$ », de « 62,10 \$ à compter du 1^{er} août 2003 ».

3(2) Subsection 6(2) is amended by striking out "\$26.30 per day effective August 1, 2002" and substituting "\$26.40 per day effective August 1, 2003".

4(1) Subsection 6.1(2) is amended
(a) by adding "or common-law partner" after "spouse"; and

(b) by adding "or common-law partners" after "spouses".

4(2) Clause 6.1(3)(b) is amended by adding "or common-law partner" after "spouse".

4(3) Subsection 6.1(3.1) is amended by replacing Items 1 and 2 with the following:

1. If the insured person's net income is between \$12,993.47 and \$26,809.59, that income is to be reduced by 5.66038% for the purpose of calculating the reduction under subsection (1) or (2).
2. If the insured person has a spouse or common-law partner who resides outside of a health facility and the spouses' or common-law partners' combined net income is between \$36,811.47 and \$50,627.59, that income is, for the purpose of calculating the reduction under subsection (3), to be reduced by an amount equal to 5.66038% of the combined net income minus \$23,818.

5 Clauses 6.2(2)(b) and 6.3(2)(b) are amended by striking out "\$26.30" and substituting "\$26.40".

6 Subsection 6.4(1) is amended
(a) in the section heading, by adding "or common-law partner" after "spouse";

4(3) Le paragraphe 6.1(3.1) est modifié par substitution, aux points 1 et 2, de ce qui suit :

1. Aux fins du calcul de la réduction que prévoit le paragraphe (1) ou (2), le revenu net de l'assuré est réduit de 5,66038 % s'il se situe entre 12 993,47 \$ et 26 809,59 \$.
2. Si le revenu net combiné de l'assuré et de son conjoint ou de son conjoint de fait se situe entre 36 811,47 \$ et 50 627,59 \$, et que le conjoint ou le conjoint de fait réside en dehors d'un établissement de santé, le revenu est, aux fins du calcul de la réduction que prévoit le paragraphe (3), réduit d'un montant équivalent à 5,66038 % du revenu net combiné, duquel ont été retranchés 23 818 \$.

5 Les alinéas 6.2(2)b) et 6.3(2)b) sont modifiés par substitution, à « 26,30 \$ », de « 26,40 \$ ».

6 Le paragraphe 6.4(1) est modifié :
a) dans le titre, par adjonction, après « conjoint », de « ou conjoint de fait »;

(b) by adding "or common-law partner" after "spouse" wherever it occurs;

(c) in clause (b), by striking out "\$22,901. plus \$7,200." and substituting "\$23,355. plus \$7,200."

b) dans le passage introductif et dans l'alinéa a), par adjonction, après « le conjoint », de « ou le conjoint de fait », dans l'alinéa b), par adjonction, après « et de son conjoint », de « ou de son conjoint de fait » et dans l'alinéa c), par adjonction, après « et son conjoint », de « ou son conjoint de fait »;

c) dans l'alinéa b), par substitution, à « 22 901 \$, plus 7 200 \$ », de « 23 355 \$, plus 7 200 \$ ».
