Manitoba Regulation 52/93 amended

1 The Personal Care Services Insurance and Administration Regulation, Manitoba Regulation 52/93, is amended by this regulation.

2(1) Subsection 6(1) is amended by striking out "\$73.40 per day effective August 1, 2010" and substituting "\$76.00 per day effective August 1, 2012".

2(2) Subsection 6(2) is amended by striking out "\$31.30 per day effective August 1, 2010" and substituting "\$32.50 per day effective August 1, 2012".

3 Subsection 6.1(3.1) is amended by striking out items 1 and 2 and substituting the following:

1. If the insured person's net income is between \$16,276.39 and \$33,076.76, that income is to be reduced by 5.66038% for the purpose of calculating the reduction under subsection (1) or (2).

Modification du R.M. 52/93

1 Le présent règlement modifie le Règlement sur l'assurance relative aux services de soins personnels et l'administration des foyers de soins personnels, R.M. 52/93.

2(1) Le paragraphe 6(1) est modifié par substitution, à « 73,40 \$ à compter du 1^{er} août 2010 », de « 76,00 \$ à compter du 1^{er} août 2012 ».

2(2) Le paragraphe 6(2) est modifié par substitution, à « 31,30 \$ à compter du 1^{er} août 2010 », de « 32,50 \$ à compter du 1^{er} août 2012 ».

3 Les points 1 et 2 figurant au paragraphe 6.1(3.1) sont remplacés par ce qui suit :

1. Aux fins du calcul de la réduction que prévoit le paragraphe (1) ou (2), le revenu net de l'assuré est réduit de 5,66038 % s'il se situe entre 16 276,39 \$ et 33 076,76 \$.

2. If the insured person has a spouse or common-law partner who resides outside of a health facility and the spouses' or common-law partners' combined net income is between \$47,692.29 and \$64,483.76, that income is, for the purpose of calculating the reduction under subsection (3), to be reduced by an amount equal to 5.66038% of the combined net income minus \$31,416.

2. Si le revenu net combiné de l'assuré et de son conjoint ou de son conjoint de fait se situe entre 47 692,29 \$ et 64 483,76 \$, et que le conjoint ou le conjoint de fait réside en dehors d'un établissement de santé, le revenu est, aux fins du calcul de la réduction que prévoit le paragraphe (3), réduit d'un montant équivalent à 5,66038 % du revenu net combiné, duquel ont été retranchés 31 416 \$.

4 Clauses 6.2(2)(b) and 6.3(2)(b) are amended by striking out "\$31.30" and substituting "\$32.50".
