**Milk Quality Regulation, amendment\***

**Manitoba Regulation 135/2017 amended**

**1 The *Milk Quality Regulation*, Manitoba Regulation 135/2017, is amended by this regulation.**

**2 Section 1 is amended by adding the following definition:**

**"Dairy Farmers of Manitoba Equipment and Production Program"** means the program adopted by the board of directors of the Dairy Farmers of Manitoba which includes requirements for the equipment and procedures for the storage, transportation and marketing of milk by producers to the board.

**3(1) Subsection 4(2) is amended by striking out "or" at the end of clause (a), adding "or" at the end of clause (b) and adding the following as clause (c):**

(c) the marketing of milk that has been produced at a facility that is not equipped or operated in accordance with the applicable provisions of the Dairy Farmers of Manitoba Equipment and Production Program.

**3(2) Subsection 4(4) is amended by striking out "clause (2)(d)" and substituting "clause (3)(d)".**

**3(3) The following is added after subsection 4(6):**

**4(7)** A producer who commits a contravention of clause 4(2)(c) shall pay a penalty as established by the board and outlined in Schedule B (Dairy Farmers of Manitoba Equipment and Production Program Fees, Charges and Penalties).

**4 Schedule B to this regulation is added after Schedule A.**

**Coming into force**

**5 This Regulation comes into force on December 1, 2018, or on the date it is registered under *The Statutes and Regulations Act*, whichever is later.**

EQUIPMENT AND PRODUCTION PROGRAM FEES,  
CHARGES AND PENALTIES

Section number of program	Fees, charges and penalties	Rate
1 a.	Bulk tank not meeting tank capacity requirement	\$100.00 penalty in addition to stop charge
1 b.	Calibration not done within 90 days	\$1.00/hl penalty until calibration done
1 c.	5 year calibration fee	As per contract in force between DFM and calibration company
1 c.	5 year calibration not done within 90 days of anniversary date	\$1.00/hl penalty until calibration done
1 d.	No dipstick or non-approved dipstick	\$1.00/hl penalty until approved dipstick installed
1 e.	non-compliant slope on bulk tank	\$1.00/hl penalty until slope corrected
2 a.	providing less or no 5 hour window for pick-up	\$100.00 in addition to stop charge
