### **Canadian Turkey Marketing Agency Levies Regulation for Manitoba\***

---

Regulation 101/2003  
Registered June 19, 2003

#### **Definitions**

**1** In this regulation,

"**Agency**" means the Canadian Turkey Marketing Agency;

"**Board**" means the Manitoba Turkey Producers;

"**processor**" means any person engaged in the business of processing turkey, or using turkey in manufacturing within Manitoba;

"**producer**" means a person engaged in the production and marketing of turkey locally within Manitoba;

"**turkey**" means a turkey of any variety, grade or class.

#### **Levy imposed on producers**

**2** A levy is hereby imposed on each producer of \$0.016 per kilogram (live weight) of turkey marketed by such producer locally within Manitoba.

#### **Due date of levy**

**3** The levy imposed under this regulation shall be due and payable by the producer to the Agency at the time and place of the marketing of the turkey by the producer.

#### **Appointment of agent**

**4** The Agency hereby appoints the Board as its agent for the purpose of collecting the levies imposed by section 2.

\* This Regulation is made under the *Canadian Turkey Marketing Agency Delegation Regulation*, Manitoba Regulation 184/2000, and is Regulation No. 1, 2003 of the Canadian Turkey Marketing Agency.

**Processor's obligation to deduct and to remit**

**5** Each processor shall at the time it takes delivery of turkey deduct from the monies payable for such turkey all levies payable by the producer to this Agency and shall forward such levies to the Board at its office, Unit 206 - 1460 Chevrier Blvd., Winnipeg, Manitoba R3T 1Y6, not later than seven days following the last day of each week in which the turkey was received.

**Producer's obligation to remit if not deducted**

**6** Every producer shall forward to the Board at its office, Unit 206 - 1460 Chevrier Blvd., Winnipeg, Manitoba R3T 1Y6, all levies payable by such producer under this regulation in respect of turkey marketed by such producer in any week that were not deducted and forwarded to the Board by the person who received the turkey from the producer, not later than seven days following the last day of the week in which such turkey was marketed.

**Non-application of regulation**

**7** This regulation does not apply to any person who is exempt from registering with Manitoba Turkey Producers under subsection 27(3) of the *Manitoba Turkey Producers' Marketing Plan Regulation*, Manitoba Regulation 248/87 R, with respect of any turkey raised by that person and delivered by that person directly to any individual for consumption by that individual and that person's immediate family or any one of them.

**Repeal**

**8** The *Canadian Turkey Marketing Agency Levies Regulation for Manitoba*, Manitoba Regulation 84/2001, is repealed.
