# Non-Potable Intoxicating Substances, Stomach Bitters and Rubbing Alcohol Regulation

#### INTERPRETATION

# Interpretation

**1** In this regulation,

"Act" means The Liquor Control Act;

"denatured alcohol" means ethyl alcohol that has been made unfit for human consumption as a beverage by the admixture of a nauseating or poisonous substance such as, but not limited to, methyl alcohol, pyridene and benzene;

"**licensed pharmacist**" means a pharmacist licensed under *The Pharmaceutical Act*:

"licensed pharmacy" means a pharmacy licensed under *The Pharmaceutical Act*:

"manufacturer" includes a producer or packager;

"**principal display panel**" has the same meaning as it has under the *Consumer Packaging and Labelling Act* (Canada);

"retail sale" has the same meaning as it has under The Retail Sales Tax Act;

"retailer" means a person who in the course of business, sells, offers to sell or displays for sale, goods to the public;

"**rubbing alcohol**" means isopropyl alcohol, and ethyl alcohol to which methyl alcohol or any other denaturant is added, in a container that is labelled on the principal display panel, pursuant to the *Consumer Packaging and Labelling Act* (Canada), as "rubbing alcohol", "rubbing alcohol compound", "denatured ethyl alcohol", or "isopropyl alcohol"; and

"stomach bitters" means any tonic containing more than 1% alcohol by volume in which herbs or roots have steeped or which has been impregnated with a bitter medicine.

#### NON-POTABLE INTOXICATING SUBSTANCES

## Designated substances

- **2** The following substances are designated non-potable intoxicating substances pursuant to subsection 11(3) of the Act:
  - (a) any extract, essence, tincture, or any food flavouring containing alcohol;
  - (b) any perfume, lotion, disinfectant, germicide, antiseptic, spray, polish or other similar preparation of a solid, semi-solid or liquid nature containing alcohol and not designed or intended by the maker or producer to be used as a beverage;
  - (c) denatured alcohol or any preparation containing denatured alcohol; or
  - (d) any cooking wine or cooking liquor or other similar substance containing more than 1% alcohol by volume and used for cooking, other than those cooking wines, cooking liquors or other similar substances that fall within the definition of "liquor" under the Act.

# Prohibition re sale of non-potable intoxicating substances

**3** No person shall sell, offer to sell or display for sale, for use as a beverage, a non-potable intoxicating substance.

# Cooking wine or cooking liquor

- **4(1)** No retailer shall sell, offer to sell or display for sale any substance referred to in clause 2(d) that contains 20% or more alcohol by volume.
- **4(2)** No retailer shall sell any substance referred to in clause 2(d) that contains less than 20% alcohol by volume, unless the retailer
  - (a) makes diligent inquiries of the purchaser and is satisfied that the substance will not be used as a beverage;
  - (b) makes diligent inquiries to ascertain that the purchaser is 18 years of age or over: and
  - (c) makes diligent inquiries to ascertain that the purchaser is not intoxicated at the time of the sale.

### STOMACH BITTERS AND RUBBING ALCOHOL

#### Stomach bitters

**5(1)** Stomach bitters are declared to be liquor pursuant to subsection 11(1) of the Act.

**5(2)** The maximum size of container in which stomach bitters may be sold is 113.7 ml (four ounces).

## Rubbing alcohol

**6** Rubbing alcohol is declared to be liquor pursuant to subsection 11(1) of the Act.

#### Conditions of sale

- **7** Stomach bitters or rubbing alcohol may be sold
  - (a) where the sale is not a retail sale within the meaning of *The Retail Sales Tax Act*, by a manufacturer or wholesaler
    - (i) to another wholesaler or, respecting rubbing alcohol only, to another manufacturer.
    - (ii) to a person for industrial, manufacturing, scientific or agricultural use, or
    - (iii) to a licensed pharmacist;
  - (b) by a licensed pharmacist from a dispensary in a licensed pharmacy.

# Repeal

**8** The Stomach Bitters Regulation, Manitoba Regulation 422/88, the Rubbing Alcohol Regulation, Manitoba Regulation 96/90 and the Non-Potable Intoxicating Substances Regulation, Manitoba Regulation 126/92, are repealed.
