- I am entitled to up to 50% of the funds accrued in the member's pooled registered pension plan account during the marriage or common-law relationship.
- I have a legal right to waive my entitlement.
- If I sign this waiver,
 - I will not receive my entitlement to any of the funds; and
 - the funds will instead be paid to the member's designated beneficiary or, if there is no designated beneficiary, to the member's estate.

I certify that:

- I have read this waiver and understand it.
- I have read the statement provided under section 23 of the Regulation.
- I am aware of the consequences of waiving my entitlement to any of the funds accrued in the member's pooled registered pension plan account during the marriage or common-law relationship and waive my entitlement despite the consequences.
- I am signing this waiver of my own free will without duress, coercion or compulsion of any kind.
- I have received independent legal advice with respect to my rights and the effect of this waiver.
- I realize that this form only gives a general description of the legal rights I have under the Act and the Regulation, and if I want to understand exactly what my legal rights are, I must read the Act and the Regulation and seek legal advice.

I hereby waive my entitlement to any of the funds accrued in the member's pooled registered pension plan account during the marriage or common-law relationship by signing this form in the presence of a witness.

This form must be completed by the spouse, former spouse, or former common-law partner of a member who — after the member's death — wants to waive the entitlement to a division of the funds in a member's pooled registered pension plan (PRPP) account resulting from a breakdown of the relationship.

Before completing this form, you must obtain independent legal advice and should consider speaking to a financial advisor who can explain the implications of this consent.

This form must be

- completed in its entirety;
- signed by the member's spouse, former spouse or former common-law partner;
- witnessed;
- filed with the administrator; and
- used for funds in a PRPP subject to *The Pooled Registered Pension Plan (Manitoba) Act.*

Definitions for the Purpose of this Waiver

Administrator means the administrator of the applicable pooled registered pension plan.

Common-law partner of an individual means

(a) a person who, with the individual, registered a common-law relationship under section 13.1 of *The Vital Statistics Act*; or

(b) a person who, not being married to the individual, cohabited with him or her in a conjugal relationship

- (i) for a period of at least three years, if either of them is married, or
- (ii) for a period of at least one year, if neither of them is married.

Member means a person with a PRPP account subject to *The Pooled Registered Pension Plans (Manitoba) Act.*
