- 2. To manage, handle and administer the property referred to in paragraph #1.
- 3. To make an inventory of the property of the vulnerable person and to file an accounting of the property, debts, liabilities, receipts and disbursements of the vulnerable person in accordance with The *Vulnerable Persons Living with a Mental Disability Act and regulations.*
- 4. As a fiduciary, to perform the duties and exercise the functions of a substitute decision maker diligently, with honesty and integrity and in good faith, for the benefit of the vulnerable person.
