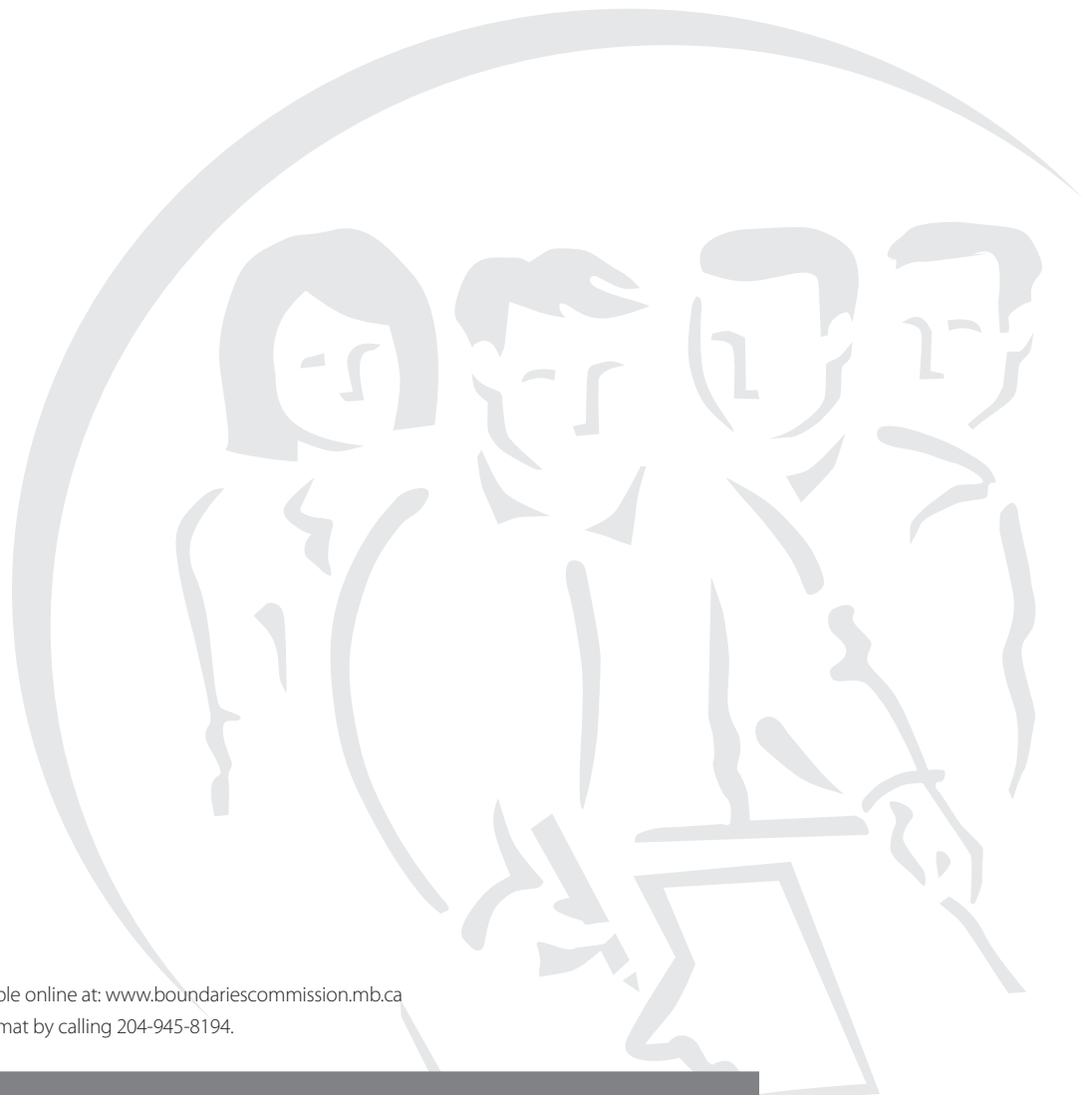

# INTRODUCTION

## COMMISSION OVERVIEW

The Electoral Divisions Boundaries Commission reviews and, where necessary, makes changes to the names and boundaries of Manitoba's electoral divisions pursuant to *The Electoral Divisions Act*. As the population of Manitoba changes, it is necessary to review electoral boundaries to ensure effective representation for everyone. If an electoral division has an increase or decrease in the population, the boundaries for that electoral division may need to change.

In determining the area and boundaries of any electoral division, the Commission not only considers population factors, but also human factors such as special diversity or community of interests of the people who live there.

The Commission is non-political and independent of government. The boundaries review is a consultative process and the Commission benefits greatly from comments and concerns expressed by the public via public hearings or written submissions.

The Commission meets every 10 years and uses the most recent census data (the 2008 Commission used 2006 census data compiled by Statistics Canada). The Commission must submit its report by December 31, 2008. The last boundary review had been in 1998.

## COMMISSION MEMBERS

### Legislative Requirements

The members of the Commission are members by virtue of the offices they hold. Section 8(2) of *The Electoral Divisions Act* specifies the membership of the Commission as follows: the Chief Justice of Manitoba, the President of each of the University of Manitoba, Brandon University and the University College of the North, and the Chief Electoral Officer of Manitoba.

Section 8(6) of *The Electoral Divisions Act* states that if the Commission is required to perform or is performing duties under *The Electoral Divisions Act* and there is a vacancy on the Commission or any member is unable to act for any reason, his or her membership on the Commission will be filled by the following persons:

- a. In the case of the Chief Justice of Manitoba, by the Chief Justice of the Queen's Bench;
- b. In the case of a university president, by the dean of the faculty of arts of that university;
- c. In the case of the Chief Electoral Officer, by the Deputy Chief Electoral Officer.

When the present Commission was being constituted, it was known that the President of the University of Manitoba would be leaving her position effective July 1, 2008, at a time when the Commission would have started, but not finished its work. If the new President of the University of Manitoba had been required to assume membership on the Commission in July, 2008, he would have had little or no knowledge of the Commission's prior work. Accordingly, pursuant to Section 8(6) of *The Electoral Divisions Act*, the Dean of the Faculty of Arts of the University of Manitoba assumed membership on the Commission instead of the President of the University.

The biographies of the members of the Commission are included as Appendix "A" to this report.

# MANDATE

## LEGISLATION

The Commission is governed by *The Electoral Divisions Act*, relevant portions of which are highlighted throughout this final report. *The Electoral Divisions Act* is available, free of charge and in full, from a number of sources. It can be viewed online at Manitoba Laws at <http://web2.gov.mb.ca/laws> or on the Commission's website at <http://www.boundariescommission.mb.ca> or at the Legislative Library, or at any public library.

## GUIDING PRINCIPLES

The right to vote is more than the right to cast a ballot. The right to vote is grounded in the right to effective representation, a concept which should not be confused with absolute voter parity. In addition to considering certain factors which can impact the achievement of effective representation, the Commission is also required to respect the statutory framework for population deviations between electoral divisions.

The broad principles which guide the Commission cannot be read in isolation. One principle is very much tied to the other.

One person one vote is important; however it is not the only factor taken into account when attempting to achieve effective representation. Justice McLachlin had the opportunity of specifically considering this issue in 1991 as a member of the Supreme Court of Canada in the Saskatchewan reference case. She wrote:

“...deviations from absolute voter parity may be justified on the grounds of practical impossibility or the provision of more effective representation. Beyond this, dilution of one citizen's vote as compared with another's should not be countenanced. I adhere to the proposition asserted in Dixon, at p. 414, that “only those deviations should be admitted which can be justified on the ground that they contribute to better government of the populace as a whole, giving due weight to regional issues within the populace and geographic factors within the territory governed.”

Focusing on effective representation is the best way of giving meaning to enhancing the values of a free and democratic society. *The Electoral Divisions Act* provides legal parameters for the variations for the number of people in an electoral division and enunciates a number of critical concerns for effective representation to be taken into consideration by the commission.

# PROCESS

## METHODOLOGY

The process of drawing the electoral division boundaries involves dividing the total population of Manitoba by 57, which is the number of provincial electoral divisions as set forth in subsection 7(1) of *The Electoral Divisions Act*. Section 9(3) of *The Electoral Divisions Act* defines total population as the population of the province as determined by the census of population compiled by Statistics Canada in the year 2006 or in any tenth year thereafter. Dividing the total population by the number of current provincial electoral divisions establishes the population quotient.

The Commission began its work by taking the total population for Manitoba, 1,148,401, and dividing it by 57 to arrive at a population quotient of 20,147.

Using the 2006 census data, the population inside Winnipeg and the population outside of Winnipeg was calculated and it was determined that the current number of divisions both inside Winnipeg and outside Winnipeg could remain the same.

In the north the population count effectively determined that the total number of seats would remain the same.

Guided by the principle of effective representation, the Commission considered each region, the number of seats, and the interests of the people of each region to determine the boundaries of each electoral division for the next 10 years. This approach provided a practical working framework for the preparation of a preliminary map, and a subsequent consideration of each proposed electoral division on its own merits.

## ESTIMATE OF POPULATION: POTENTIAL UNDERCOUNT

One overarching issue which the Commission carefully considered and dealt with prior to releasing a set of proposed electoral division maps, was the likelihood that the population of Manitoba as a whole had not been fully counted in the 2006 census conducted by Statistics Canada.

Section 9(2) of *The Electoral Divisions Act* stipulates that if the Commission is satisfied that persons in the province have not been counted or fully counted in the 2006 census, it may use an estimate of the population prepared by Statistics Canada, the Manitoba Bureau of Statistics or another source satisfactory to the Commission.

The Commission was advised by Statistics Canada that although an effective census had been conducted in Manitoba in 2006, in the sense that Statistics Canada representatives had been present and had conducted a count in every area of the province, the total population of the province had likely been undercounted. In March 2008, Statistics Canada estimated that the extent of the undercount was 3.2%. The figure of 3.2% however was a weighted average; the undercount in the metropolitan area of Winnipeg was estimated to be 2.27%, and outside of that area, the undercount was estimated to be 4.56%.

The Commission recognized that in such circumstances, it had the discretion, pursuant to Section 9(2) of *The Electoral Divisions Act* to estimate the population "in the province, or in a specific electoral division, or on an Indian reserve". The Commission consulted Statistics Canada and the Manitoba Bureau of Statistics regarding distributing the undercount to the various divisions in the province. Neither organization could authoritatively distribute the undercount. Accordingly, the Commission assessed various other sources of population data in terms of reliability and accuracy, using criteria which included the source of the data, the nature of the data and the applicability of the data to some or all of the electoral divisions within the province.

The Commission exercised its discretion under Section 9(2) of *The Electoral Divisions Act* and decided not to use an estimate of population to adjust for the undercount, either on a province-wide basis, or with respect to specific electoral divisions or First Nations communities. The Commission made this decision because it concluded that the estimated undercount could not be reliably and fairly distributed between the electoral divisions in the province. The Commission also concluded that using an estimate of population to adjust for the undercount would change the population quotient and potentially distort population relationships between individual electoral divisions.

Accordingly, the Commission proceeded to do its work based on the results of the census conducted by Statistics Canada in 2006.

## EXISTING 1998 BOUNDARIES

On April 14, 2008 the Commission released information which included the 1998 electoral boundaries, the 2006 Census population counts for each existing electoral division, and the variations from the population quotient that would result if the electoral boundaries were not changed.

This information was made public simultaneously with the launch of the commission's website and a press release announcing the commencement of the commissions work. Maps, population counts and the variations were also distributed to municipalities, First Nations communities, town and city councils, MLA's, political parties and others.

The information demonstrated the need for substantial change. Twelve of the existing electoral divisions were outside the permitted variance from the population quotient and three electoral divisions were within 1% of

the permitted variance. For example, the former electoral division of Flin Flon exhibited a -35.67% variance, although only a +/-25% variance is allowed, and electoral divisions such as Fort Whyte and Steinbach had variances of +47.07% and +25.16% respectively, although the permitted variance for those divisions is +/-10%.

After the information release on April 14, 2008, the public was invited to provide written submissions to the Commission before any further decisions were made relating to the proposed boundaries.

Based on the information released to the public, the written submissions received and the preliminary discussions of the Commission, work began to develop a set of proposed electoral division maps.

## **PROPOSED ELECTORAL DIVISION BOUNDARIES**

The Commission approached its work trying to set each electoral division's population as closely as possible to the quotient. The Commission, where necessary, altered the preliminary electoral division boundaries in order to adjust population counts and to account for special factors while still attempting to bring approximate equality of population to all electoral divisions.

Section 11(3) of *The Electoral Divisions Act* stipulates that the Commission may vary the population of each electoral division but within certain limits. The variation may be +/-10% where the electoral division is situated wholly south of the 53rd parallel, or +/-25% where the electoral division is situated wholly or partially north of the 53rd parallel.

In addition to population statistics, when determining the area to be included in an electoral division, the Commission must also take into consideration the community or diversity of interests of the population, the means of communication between the various parts of the area being considered, physical features, existing boundaries of rural municipalities and other relevant factors.

In assessing any possible population variations, and in determining the area to be included in the boundaries of any electoral division, the Commission considers: special geographic conditions, including the sparsity, density, and relative rate of growth, or population of a region, the accessibility of a region and the size or shape of a region and any special diversity of interests of the inhabitants of a region.

On June 25, 2008 the Commission distributed maps of the proposed boundaries to municipalities, First Nations communities, town and city councils, MLAs, political parties and others. The same maps were made available to the general public, free of charge, and were also posted on the Commission website. On the same day, a news release outlined some of the proposed changes, and publicized the dates and locations of public hearings and invited the public to register in advance of the hearings in order to make presentations. In addition, extensive advertising was done in daily and weekly newspapers across the province and on rural and northern radio encouraging the public to take part in the process. This began the consultative portion of the process.

## **PUBLIC HEARINGS AND SUBMISSIONS**

The Commission used its website and extensive advertising to provide information to the public. The website outlined information about the electoral division populations, the proposed boundaries, the governing legislation, and the ways in which the public could participate in the process.

In return, the general public provided information to the Commission by way of written submissions. Members of the public also registered on-line or by phone to provide oral presentations to the Commission at public hearings.

Throughout the month of September, the Commission held 12 public hearings in 10 locations around the province. The Commission heard 56 presentations at the public hearings and also considered 44 written submissions sent to the Commission via regular mail, fax and email. Three of the written submissions were signed by multiple individuals, so in total over 260 people participated in the public consultation part of the process.

At virtually every hearing, presenters recognized the difficulty of the Commission's task and acknowledged the challenge faced by the Commission in balancing many competing, but legitimate objectives. The submissions and suggestions made by the public presenters were insightful -- providing both a broad view of public concerns, and community and neighbourhood perspectives -- and were invaluable to the Commission's work.

## FINAL REPORT

Before December 31, 2008, the final report, including the final electoral division boundaries and names of the electoral divisions must be presented to His Honour the Lieutenant Governor and to the Speaker of the Assembly. If the Assembly is sitting, the Speaker must table it in the Assembly. If the Assembly is not sitting, the Clerk of the Assembly will distribute the final report to each member of the Assembly, and the Speaker will table it in the Assembly within seven days of the commencement of the next sitting.

In 1998, the Commission's proposed changes were fixed by an Act of the Legislature after consideration by the Legislative Assembly. A 2006 change in *The Electoral Divisions Act* stipulated that the changes will come into force on the first dissolution of the Legislature after the end of the year the report is submitted and ensures that the final report will have the same force and effect as if it were enacted by the Legislature (Section 10(5)).

## FINAL DECISIONS

In reaching final decisions with respect to electoral boundaries, the Commission must fulfill the statutory requirements of *The Electoral Divisions Act*, including the requirement for 57 electoral divisions within the province, and the obligation to ensure that the variations from the population quotient are within the permitted limits. Changes to electoral divisions, even minor changes, will often cause a cascade or ripple effect across various divisions and sometimes entire regions of the province. The Commission worked diligently to respect the recommendations that were made at the public hearings and in the submissions while keeping within the requirements of the legislation.

## NORTHERN MANITOBA

It was apparent from both written and oral submissions that the proposed electoral division of Flin Flon was of particular concern. When the 2006 census data was analyzed in relation to the existing (1998) boundaries, Flin Flon was approximately 35% below the established population quotient per electoral division. Under section 11(3)(b) of *The Electoral Divisions Act*, the population of electoral divisions situated wholly or partially north of the 53rd parallel may be 25% greater or less than the population quotient. The Commission was therefore required to find a way of adding population to the Flin Flon electoral division to bring it within 25% of the population quotient.

Following its proposed boundaries, the Commission received a number of submissions requesting that the common boundary between the electoral divisions of Flin Flon and Rupertsland remain the same as the 1998 boundary. Submissions were made regarding the challenges regarding transportation within Flin Flon in the proposed map. Travel from one side of the division to the other would require flying through Winnipeg. Submissions were also made on the challenges facing isolated communities in the north and unique community of interests especially within the existing Rupertsland electoral division were compelling. In particular, the submissions of the Town of Churchill and the First Nation of Fox Lake with regard to their strong historical and cultural ties to the east side of the province were persuasive. As a result the Commission decided that the common boundary between Flin Flon and Rupertsland would remain as it was in 1998. The Commission was then faced with finding another way to ensure that the Flin Flon electoral division complied with the statutory requirements of *The Electoral Divisions Act*.

This was a difficult task; one not taken lightly by the Commission. The changes to the proposed boundaries had a ripple effect across the north and in order to maintain the 1998 northwestern boundary of Rupertsland,

the population of the Flin Flon electoral division had to be increased in other ways. Following a significant amount of discussion and careful consideration of all of the alternatives, the boundary between the Flin Flon and Thompson electoral divisions was moved to follow the boundary of the Local Government District of Mystery Lake thus placing the community of Nelson House into the Flin Flon electoral division, as had been recommended in a number of the public submissions made to the Commission.

In addition to this particular change, the Commission also attempted to keep variations from the population quotient throughout the North reflective of the uniqueness the area. Accordingly, Oxford House was moved into the Thompson electoral division -- Oxford House has winter road access to the City of Thompson and can be accessed by air any time of the year from Thompson.

Flin Flon and Rupertsland both consist of vast areas and contain many remote communities. The Commission weighed the permissible deviation from the quotient against the unique geography of the area and arrived at a greater variation for Flin Flon and Rupertsland. Thompson and The Pas were kept closer to the quotient with Thompson at a slightly lower deviation to accommodate the anticipated growth in this division.

As a result of the changes made by the Commission, Flin Flon has a final population variation of -24.31%, Rupertsland, -22.77%, The Pas, +1.88% and Thompson, -5.97%. The final population deviation of The Pas remained the same as noted on the proposed boundary map.

Lastly, the Commission received comments that the name of the electoral division of Rupertsland should be changed. The Commission determined the Rupertsland electoral division should be renamed to the Kewatinook electoral division. Kewatinook in Cree means "from the north". The Commission is confident that changing the name of the electoral division from Rupertsland to Kewatinook best honours the history of the land.

## **SOUTHERN MANITOBA**

In its final decision, the Commission has, so far as possible, endeavoured to respect *The Electoral Divisions Act* direction to include the whole area of a rural municipality in the same electoral division in order to maintain existing communities of interest. The Commission is pleased that of a total of 118 rural municipalities and local government districts in the province, only 7 rural municipalities have been divided. It should be noted that two of those 7 rural municipalities were divided because of significant increases in population in their respective areas. Hanover, including the growing community of Steinbach, exceeded the permitted 10% variation from the population quotient, and Stanley, including the growing communities of Winkler and Morden, was within 1% of the permitted 10% variation from the population quotient.

The Commission heard submissions calling for the reunification of the Tri-Roads Planning District, comprising of the rural municipalities of Shellmouth-Boulton, Silver Creek and Russell, and including the towns of Russell and Binscarth. The Commission was able to accommodate these submissions.

The Commission received numerous submissions asking that the regional distribution of electoral seats in southern Manitoba remain unchanged. While the Commission understood the concerns that were raised, the decline in population in southwestern Manitoba coupled with the increasing population distribution elsewhere in the province meant that keeping the same number of seats in the southwestern half of the province was not possible. The total number of seats assigned to southern Manitoba remained unchanged from the proposed map, and the new configuration reflects the increased population growth in the southeastern parts of the province.

The Commission received over 100 signed form letters and heard presentations during the public hearings advocating that the rural municipality of Daly, including the town of Rivers, be moved to Minnedosa-Russell, in the same electoral division as Rapid City. The commission also heard from the rural municipality of Glenwood and the town of Souris that their relationship with the Minnedosa area had become very strong over the last 10 years and it would be in the best interest of this municipality to remain with the Minnedosa-Russell division. In order to accommodate these changes to the final boundaries, the Commission was required to place the rural municipalities of Miniota and Hamiota in the electoral division of Arthur-Virden.

The Commission also heard submissions that the rural municipality of Ste. Rose and the town of Ste. Rose were pleased with the proposed changes to electoral boundaries and wished to stay within the electoral division with Dauphin. The Commission agreed; accordingly, the town and the entire rural municipality of Ste. Rose remain within the electoral division of Dauphin-Roblin.

Submissions were made with regard to the community of St. Laurent. The submissions consistently recommended that the community of St. Laurent be part of the Interlake electoral division for cultural and geographic reasons. The Commission accommodated these requests; accordingly, boundary lines were altered to include St. Laurent in the electoral division of Interlake, and to place the rural municipality of Armstrong in the electoral division of Lakeside. Other suggestions recommended moving the Ebb and Flow First Nation communities to the east side of Lake Manitoba but this could not be accommodated because this would have had a cascade effect among various electoral divisions.

The Commission was able to accommodate several more subtle suggested changes which included using Highway 59 as a better “on the ground” western boundary of the Steinbach electoral division, moving the southern boundary of Morden-Winkler so as not to split the communities of Choritz, Friendsruh, and Schanzenfeld, and to move the southern boundary of the Portage la Prairie electoral division to include all of the Long Plain First Nation land.

It was submitted that the former electoral division of Tache be renamed Dawson Trail and include the rural municipality of Ste. Anne in order to keep francophone communities together as much as possible. This recommendation was accommodated by the Commission.

The final map reflects those submissions and concerns the Commission was able to accommodate while keeping within the requirements of *The Electoral Divisions Act*.

The Commission agreed with the suggestion that the names of electoral divisions should not be limited to the name of a particular town or city, and that historical or regional names for electoral divisions should also be carefully considered.

The Commission made the following changes to the names of various electoral divisions in southern Manitoba:

- a. Carman-Pembina was changed to Midland as was suggested in a submission;
- b. Dauphin-Roblin was changed to Dauphin, which is the name of both the town and the rural municipality which make up over half the population of the division;
- c. Minnedosa-Russell was changed to Riding Mountain;
- d. Taché was changed to Dawson Trail.
- e. Turtle Mountain was changed to Spruce Woods;

## WINNIPEG

In the submissions and presentations received, one of the major concerns related to the constituency of River East. Under the Commission’s proposed boundaries, the electoral division of River East took on a distinctly different character. In the course of public presentations, it was brought to the Commission’s attention that in the proposed electoral division map, the River East School and Community Centre were no longer part of the proposed River East electoral division and that the proposed boundary of the electoral division no longer touched the river. This feedback provided a good example of the important positive contribution the public made through their submissions. By re-drawing the River East and Rossmere electoral divisions with a greater east/west orientation, the Commission was able to re-establish some of the characteristics of the existing River East electoral division, without compromising the characteristics of the Rossmere electoral division.

The Commission also heard requests to use the Assiniboine River as the boundary between Northwest and Southwest Winnipeg. Although the electoral division of Fort Rouge had straddled both sides of the Assiniboine River when the 1998 electoral division boundaries were in place, with substantial population shifts since 1998 the Commission was able to adjust the boundary so that all of the Fort Rouge electoral division was south of the Assiniboine River. This created a small ripple effect north of the river and adjustments to other electoral division boundaries were made accordingly.

Suggestions were also made that the neighbourhoods of Weston and Brooklands be reunited. This was accomplished by including the Weston and Brooklands neighbourhoods in the Inkster electoral division.

A request was made that a small pocket of homes south of the air force base and north of Ness Avenue be included within the St. James electoral division. The Commission was able to accommodate this request.

There was also a submission made with regard to the area south of the Grant Park shopping centre. Although that area was close to both River Heights and Fort Rouge, the area was formerly in the proposed electoral division of Pembina-Jubilee. The Commission was able to address community concerns by placing most of this area either into the River Heights electoral division or the Fort Rouge electoral division.

Some submissions pointed out that the proposed division of Fort Whyte would not only experience future growth via the new community of Waverly West, but also via continued growth in established communities. This submission proposed that Waverly West be moved into the electoral division of St. Norbert. In the end, the Commission allocated the area now known as Waverly West between the two electoral divisions of St. Norbert and Fort Whyte, endeavouring to lessen the impact such intense growth would cause in only one division. Cadboro Road was chosen as the boundary because it is a highly visible artery in the community.

The Commission made the following changes to the names of various electoral divisions in Winnipeg to better reflect the communities within the boundaries of each:

- a. Fort Garry was changed to Fort Richmond;
- b. Inkster was changed to Tyndall Park.
- c. Pembina-Jubilee was changed to Fort Garry-Riverview;
- d. Wellington was changed to Logan;

## CONCLUDING OBSERVATIONS

Due to amendments in 2006, the Commission is now comprised of five Commissioners, rather than three. The change from a three-person Commission to a five-person Commission was smooth and seamless. The additional two Commissioners, the Presidents of Brandon University and the University College of the North, undoubtedly added important perspectives to the work of the Commission.

The Commission has a suggestion for a change to *The Electoral Divisions Act*, namely that in circumstances where neither the Chief Justice of Manitoba nor the Chief Justice of the Court of Queen's Bench are able to act as a Commissioner, that the Chief Justice of Manitoba be entitled to appoint either the Associate Chief Justice of the Court of Queens Bench or the Associate Chief Justice (Family Division) of the Court of Queens Bench in his place.

## MEMBER BIOGRAPHIES

### **Richard J. Scott**

*Manitoba Chief Justice*

The Honourable Chief Justice of Manitoba Richard J. Scott became Chief Justice of Manitoba (Court of Appeal) in 1990 and first chaired the Commission in 1998. He holds a distinguished record of judicial appointments starting with Associate Chief Justice of the Court of Queen's Bench in 1985. He has chaired committees on judicial independence and ethical principles for judges. Since 2000, he has been first vice-chair of the Canadian Judicial Council and Chairman of the Judicial Conduct Committee of the Canadian Judicial Council. Chief Justice Scott has shared his experience through presentations at international judiciary conferences in Canada, Ethiopia, Australia and New Zealand.

### **Richard D. Balasko**

*Chief Electoral Officer*

Richard D. Balasko became Manitoba's Chief Electoral Officer (CEO) in 1990 after gaining 10 years of electoral experience as deputy chief electoral officer and serving as executive assistant to Canada's Chief Electoral Officer. Mr. Balasko served on the 1998 Commission, and he was secretary to the Commission in 1978 and 1988.

As CEO, Mr. Balasko has been accountable for the conduct of five provincial general elections plus by-elections as well as ongoing accountabilities under the Elections Finance Act (R.S.M. 1987, c. *President and Vice-Chancellor, University College of the North*

Dr. Denise K. Henning's education background includes degrees in urban studies and public administration (with an emphasis on qualitative research) from the University of Nebraska at Omaha. She also completed her doctoral degree from New Mexico State University in Education Administration, Higher Education with emphasis in Educational Anthropology.

Dr. Henning has developed a reputation for building relationships through a collaborative and team-spirited approach. Dr. Henning has dedicated her life to working towards inclusion and equity in academia and to increasing the knowledge and appreciation of the many heritages of Aboriginal peoples in North America.
